#### Mayor's Report:

Mayor Glasser reported that Halloween was a great success. Mayor Glasser shared that the Veterans Day Service was very successful and well attended. He thanked City Administrator Swain, Assistant City Administrator Frost, Clerk Samuelsen, the Department of Public Works, the Volunteer Fire Companies and the Police Department. Mayor Glasser was pleased with the Purple Heart Way dedication on the Bike Path and thanked Mr. Drew Holmes and the students at Atlantic County Institute of Technology. Additionally, Mayor Glasser expressed his appreciation to Commander Frolow, U. S. Congressman Van Drew, State Senator Brown and American Patriot Veteran's Advocate Marco Polio Smigliani.

#### **Administrator's Report:**

City Administrator Swain reported that the Patriots of Somers Mansion approached the State regarding use of the property between the mansion and the Atlantic County Historical Society. Mr. Swain indicated the State may transfer the property or give the City control of property and recommended the City to consider a long-term plan. Council President McGuigan looks forward to hearing from the State.

Wes Swain, City Administrator, reported and explained the Storm Water Management Plan, noting the City has a Tier A permit. The permit addresses storm water quality issues as it relates to new and existing development by implementing statewide basic requirements. The City has 43 outfall pipes, and each year they are inspected. The City operates 649 catch basins and has annual employee training.

#### **Committee Reports:**

Council President McGuigan reported that he and City Engineer had a discussion with South Jersey Gas Company (SJ Gas) relative to new types of work that SJ Gas proposed in addition to replacement of mains that includes the installation of Emergency Flow Values (EFV) for each resident that involved cutting up a number of streets. City Engineer Schneider explained that it is a safety feature that includes a number of streets that are under moratorium. In an effort not to disrupt residents with construction so soon after already experiencing repaving of their streets, Engineer Schneider discussed with SJ Gas that any street that had been repaved in the past three years would not be eligible for the installation of the EFV until a later date. Mr. Schneider informed the Governing Body and public that SJ Gas is required to restore the streets after installation of the EFV.

#### **Ordinances:**

#### Ordinance No. 10 of 2020

Introduction/First Reading

M/S- Owen/Johnston

Councilman D'Adamo motioned to amend to a 30 days turnaround, seconded by Council President McGuigan and by roll vote: D'Adamo-yes; Dill-recuse; Johnston-no; Owen-no; Toto-no; McGuigan-yes. The amendment was defeated.

The ordinance was adopted by roll call vote of those present with Councilman D'Adamo and Council President McGuigan voting no, and Councilman Dill abstaining.

City Solicitor Thomas Smith explained that the ordinance addresses the issue of short term rentals, and by statute a city can regulate rentals that are rented less than 175 consecutive days. Mr. Smith explained how the ordinance addresses inspections, fees, mercantile licenses, length of stay, number of tenants allowed, minimum nights of stay, responsibilities of the landlord of short term rentals and other requirements and regulations.

Council President McGuigan indicated that this ordinance facilitates short term rentals and opines that a new set of strangers every week in our neighbors is not right or fair for our residents.

Councilwoman Johnston indicated this ordinance will allow the City to have some control regarding the safety of tenants utilizing short term rentals. Councilwoman Johnston reported that short term rental companies intend to begin working with municipalities indicating on their website and in their agreements the requirements of municipalities. She indicated that short term rentals will generate income and tourism while giving the City some control.

City Solicitor Smith indicated that there are regulations in place to enforce rentals.

Council President McGuigan noted that the City currently has rental regulations; however, the current City Code does not facilitate short term rentals. Council President McGuigan talked to his neighborhood and opined that short term rentals will be disruptive to the neighborhood. Council President McGuigan indicated that short terms rentals could be an economic engine and bring people into town, but it is not a driving economy. Council President McGuigan shared that Northfield, Mays Landing and Linwood adopted policies for a 30-day minimum turnaround along with Egg Harbor Township, except for Anchorage Point and Seaview Harbor. He stated that Ocean City is set up as a rental community whereas Somers Point is not.

Councilwoman Johnston shared that the reviews for Air BNB's for Somers Point are very favorable noting great restaurants and a great little beach. She stated that Somers Point is not like Northfield, Linwood or Mays Landing, because we are a boating town.

#### ORDINANCE NO. 10 of 2020

An Ordinance Amending and Supplementing the Somers Point Municipal Code Chapter 169, Littering and Property Maintenance; Article V, Registration and Inspection of Certain Rental Units, Apartments and Dwelling Units.

**WHEREAS**, N.J.S.A. 40:52-1 authorizes a Municipality, by Ordinance, to license and regulate the rental of real property for a term less than 175 consecutive days for residential purposes by a person having a permanent place of residence elsewhere; and

**WHEREAS**, the City Council of the City of Somers Point recognizes that there exists a growing business for short-term residential rentals available on the internet which certain Somers Point residential property owners are availing themselves to; and

WHEREAS, the City Council of the City of Somers Point believes that it is important for purposes of health and safety to license and regulate this new form of business; and

**WHEREAS,** Chapter 169, Article V of the City's Code currently contains ordinances which provide oversight and control of the residential rental units in the City; and

**WHEREAS**, the City Council is desirous of amending and supplementing these ordinances so as to recognize, and to provide oversight of this growing business.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Somers Point, County of Atlantic, and State of New Jersey as follows:

The Somers Point Municipal Code Chapter 169, Littering and Property Maintenance; Article V, Registration and Inspection of Certain Rental Units, Apartments and Dwelling Units, is hereby amended and supplemented to add the following in the Sections denoted herein:

#### Section 169-46. Definitions.

#### **Short-Term Rental**

Any rental unit rented for a term less than 175 consecutive days for residential purposes by a person having a permanent place of residence elsewhere.

Section 169-47. Registration required; registration certificate; license.

C. Information to be provided in the registration certificate:

(13) For all short-term rentals the requirements of Subsection C(8), paragraphs (c), (d) and (i), need not be provided at the time of said registration. However, this information is to be obtained, recorded and maintained in ledger form by said Landlord and

supplied to the Code Enforcement Officer of the City of Somers Point, or his/her designee, either upon demand or at the time of the annual inspection of said rental unit as set forth in Subsection B of Section 169-48. The applicant shall also provide on the registration form—the maximum number of occupants that will be renting, occupying and/or staying at the property at any one time.

G. All short-term rentals, as operating businesses, are also required to obtain a mercantile license as set forth in Chapter 174 of this Code, and in order to maintain said license may not be rented or leased out for a time period of less than two nights.

#### Section 169-48. Certificate of Occupancy; inspection; fees.

B. (The following language shall be added at the end of this paragraph): For short-term rentals, the aforesaid inspection is not required for changes in occupancy and/or tenancy, but an inspection by the aforementioned representative of the City for the property is required to occur once a year, and shall occur within fifteen (15) days of the application for the property's mercantile license. Failure to have such an inspection conducted shall result in the immediate suspension of the right to lease the premises. The landlord of a short-term rental shall conduct quarterly self-inspection of the property for health and safety purposes using a form issued by the City's Code Enforcement Officer of the City of Somers Point, or his or her authorized designee, which completed forms shall be maintained and kept with the ledger referenced in Subsection C(13) of Section 169-47 of the within Article, and shall be provided to said designated official at the time of the inspection.

#### Section 169-50. Fees; exceptions.

(The following language shall be added as the last sentence in the first full paragraph): No owner or landlord of a short-term rental shall be required to pay a registration fee as long as they can demonstrate at the time of registration that they hold a current, valid mercantile license for the short-term rental business conducted at the property.

#### Section 169-51. Occupancy prohibitions.

F. (The following language shall be added at the end of the sentence in this Subsection): In the case of a short-term rental, the 29-day exception referenced herein is not allowed.

**BE IT FURTHER ORDAINED** that should any section, clause, sentence, phrase, provision in these amendments to ordinances be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remain portions of these ordinances.

This ordinance shall take effect upon its final passage, publication and adoption in the manner prescribed by law.

**WHEREAS**, N.J.S.A. 40:52-1 authorizes a Municipality, by Ordinance, to license and regulate the rental of real property for a term less than 175 consecutive days for residential purposes by a person having a permanent place of residence elsewhere; and

WHEREAS, in recognition of the growing business of short-term, residential rentals in the City of Somers Point, City Council has amended Chapter 169, Article V, of the Somers Point Municipal Code, which deals with the registration and inspection of certain rental units, apartments and dwelling units so as to impose safety and health requirements and regulations on such business operations; and

**WHEREAS**, the City Code currently does not reflect a mercantile fee to be imposed upon such business of operations for short-term, residential rentals; and

**WHEREAS**, the City Council of the City of Somers Point is desirous to set such a mercantile fee so as to offset, in part, the cost of implementing the associated health and safety requirements and regulations imposed by its amendment to Chapter 169, Article V, of the Somers Point Municipal Code.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Somers Point, County of Atlantic, and State of New Jersey that the Somers Point Municipal Code Chapter 174, Mercantile Licenses; Section 174-4, Fees, is hereby amended and supplemented to add the following:

This ordinance shall take effect upon its final passage, publication and adoption in the manner prescribed by law.

Resident Natalie Bailey 825 Bay Avenue complained about the volume of the meeting, she requested that each person state their name before speaking, she requested that ordinances listed on the agenda be explained to the public before voting, she requested a quarterly report on expenditures versus budget, questioned if South Jersey Gas is allowed to cut through her property and Council President McGuigan responded that they are allowed but must restore the property to its original condition. Ms. Bailey questioned the salary and wage ordinance. Council President McGuigan explained that the amounts in question represent a range of salary. Additionally, Ms. Bailey requested flashing stop signs at New York Avenue and Bay Avenue and Hospital Way and Bay Avenue. Council President McGuigan will consult with the Police Chief and City Engineer.

City Engineer, Greg Schneider, indicated that if there are any issues regarding restoration of property from South Jersey Gas, please contact the City, and he will be happy to assist the public with any repairs.

Resident Levi Fox explained that the Patriots of Somers Mansion is hoping to obtain a grant for a feasibility study.

Theresa Dougherty of 26 Dogwood Drive questioned the posting of the minutes of 9/10/20 meeting. Council President McGuigan explained that once the minutes are approved, they will be posted on the website. Ms. Dougherty expressed her concern regarding vehicles speeding on Broadway and Dogwood Drive. Council President McGuigan will alert the Police Department with her concerns. Additionally, Ms. Dougherty thanked Councilman D'Adamo for his professionalism.

Resident Joseph McCarrie expressed his concern with speeding vehicles on Broadway. Council President McGuigan explained the issues of installing speed bumps.

Natalie Bailey of 825 Bay Avenue expressed her concern of the speeding vehicles on Bay Avenue.
