WHEREAS, on August 3, 2021, a Memorandum was provided by the Planning Board Solicitor to the Mayor, Council President, and the City Solicitor wherein it was indicated that "... the Planning Board reviewed the updated zoning matrix/zoning schedule. At the conclusion of this review, the Planning Board voted unanimously to recommend that City Council move expeditiously to amend the City's Development Regulations contained in Chapter 114 to incorporate the new zoning matrix attached to this Memorandum to consolidate and simplify the area and bulk requirements of all zoning districts into a more concise and easier form." However, said Memorandum failed to identify both the comments referenced in the Planning Board Chair's correspondence of June 1, 2021, as well as the basis for any proposed changes to the area and bulk requirements; and

WHEREAS, on August 23, 2021, an email was sent by the City Solicitor to the Planning Board Solicitor wherein a clarification was sought relative to whether specific changes were being recommended to area and bulk requirements in the City since the Matrix which was intended to be sent down to the Planning Board did not contain any such changes, and also, since there were no actual comments being provided in the aforesaid Memorandum; and

WHEREAS, there has been no response from the Planning Board to this request of the City Solicitor; and

WHEREAS, the City of Somers Point ("City") and its residents have suffered harm from the opioid epidemic; and

WHEREAS, the City recognizes that the entire State of New Jersey has suffered harm as a result of the opioid epidemic; and

WHEREAS, the State of New Jersey and Atlantic County filed a lawsuit in the United States District Court to address the public nuisance that is the Opioid Epidemic, which named, among other companies, the following four Defendants ("Settling Defendants"):

- 1. Janssen Pharmaceuticals, Inc. (a prescription opioids manufacturer);
- 2. Amerisource Bergen Corp. (a prescription opioids wholesaler distributor);
- 3. Cardinal Health, Inc. (a prescription opioids wholesaler distributor); and
- 4. McKesson Corporation (a prescription opioids wholesaler distributor); and

WHEREAS, the lawsuit was subsequently transferred to the United States District Court in the Northern District of Ohio and centralized as part of *In re National Prescription Opiate Litigation,* MDL 2804; Case No. 1:17-md-2804, which is presided over by the Honorable Dan Aaron Polster, United State Federal District Court Judge; and

WHEREAS, the Settling Defendants have negotiated proposed national settlement agreements ("Proposed Settlements") with the State Attorneys General, and a Plaintiff Executive Committee-designated negotiating committee that represents approximately 4,000 local governments that have brought similar lawsuits; and

WHEREAS, the City having a population in excess of 10,000 has been included in the list of municipalities eligible to participate in the settlement proceeds; and

WHEREAS, the City has been assigned a Registration Code Number which will permit the City to register and authorize participation in the Settlement; and

WHEREAS, the deadline for submitting the required documentation is January 2, 2022; and

WHEREAS, if the Settlement is accepted and approved by the Court, the settlement proceeds will be up to Twenty-Six Billion Dollars with up to Six Hundred Twenty-eight Million Dollars allocated to the State of New Jersey and local eligible municipalities; and

WHEREAS, the goal of the State is to achieve 262 participants to maximize eligible funding; and

WHEREAS, the Proposed Settlements contain significant equitable and monetary relief, including:

- 1. An agreement by Janssen that it will discontinue the manufacture and distribution of prescription opioids products for at least the next ten years;
- 2. An agreement by Janssen that it will suspend any lobbying efforts that concern prescription opioids products;
- 3. The creation of a National Clearinghouse for wholesale distributors that will assist in the detection, suspension and reporting of suspicious orders of prescription opioids products; and
- 4. The payment of up to \$26 billion (depending upon the level of participation of state and local governments in the Proposed Settlements) in funding installments over the next 18 years, the bulk of which will be dedicated to funding abatement and prevention strategies associated with the opioids public nuisance.

WHEREAS, said Resolution held that pending further resolution, the force and effect of the resolution, and all temporary rights set forth therein, were to terminate upon the earlier of either the effective date and time of the State of New Jersey relaxing the provisions of Executive Order 107 relative to its prohibition of on-premises consumption of food or beverages at bars and restaurants and requirement of social distancing as set forth therein, or at 11:59 p.m. on July 24, 2020; and

WHEREAS, on July 23, 2020, this governing body passed Resolution No. 140-2020 which extended until September 14, 2020, the aforesaid temporary and limited expansion of the operations of bars/restaurants to their outside areas and municipal right of ways; and

WHEREAS, on September 10, 2020, this governing body passed Resolution No. 151-2020 which extended until October 23, 2020, the aforesaid temporary and limited expansion of the operations of bars/restaurants to their outside areas and municipal right of ways; and

WHEREAS, on November 4, 2020, this governing body passed Resolution No. 181-2020 which extended until January 29, 2021, the aforesaid temporary and limited expansion of the operations of bars/restaurants to their outside areas and municipal right of ways; and

WHEREAS, on January 2, 2021, this governing body passed Resolution No. 49-2021 which extended until May 17, 2021, the aforesaid temporary and limited expansion of the operations of bars/restaurants to their outside areas and municipal right of ways; and

WHEREAS, on May 13, 2021, this governing body passed Resolution No. 97-2021 which extended until September 27, 2021, the aforesaid temporary and limited expansion of the operations of bars/restaurants to their outside areas and municipal right of ways; and

WHEREAS, it is recognized by this governing body that the COVID-19 outbreak continues to cause substantial economic suffering and financial hardship for many of the restaurants in the City of Somers Point: and

Subject: Resolution Supporting the New Jersey Department of Transportation

Reconstruction of US Route 9, Chapman Boulevard to Route 30 Project

Introduced By: Council President Johnston

- **WHEREAS**, the New Jersey Department of Transportation (NJDOT) has undertaken a Concept Development Study of Route 9 from Chapman Boulevard to Route 30 in Atlantic County; and
- **WHEREAS**, the purpose of this project is to reconstruct pavement along Route 9 within the project limits, upgrade safety and operational elements where feasible, and mitigate recurring flooding along segments of the corridor; and

WHEREAS, the goals and objectives of this project are:

- Satisfy purpose and need while minimizing environmental, access, right of way, and utility impacts.
- Improve traffic safety and operations along the corridor.
- Upgrade all facilities (i.e. curb ramps, sidewalk, traffic signals) to be ADA compliant.
- Enhance bicycle and pedestrian accommodations to comply with Complete Streets Policy.
- Improve drainage conditions where feasible.
- Minimize disruptions to locals during construction.
- **WHEREAS**, this project includes pavement reconstruction along the entire length of the project which includes 22 signalized intersections and 59 unsignalized intersections; and
- **WHEREAS**, the City has completed a NJDOT funded Bicycle and Pedestrian Study by Parsons Brinckerhoff which should be fully implemented as part of this project; and
- **WHEREAS**, the NJDOT has met with the City of Somers Point to understand the City's concerns and recommendations for this project including, but are not limited to:
 - Delivery trucks make illegal left turns at Defeo Lane.
 - Repeatedly damaged storm drain between Defeo Lane and Bethel Road.
 - Safety improvements needed at Chapman Boulevard/Route 9 intersection including additional lighting and sidewalks.
 - Safety improvements needed at Bethel Road/Defeo Lane/Route 9 intersection, including a dedicated right turn only lane traveling eastbound on Bethel Road onto southbound Route 9.
 - Safety improvements needed at Ocean Heights Avenue/Route 9 intersection.
 - The installation of ADA compliant curb ramps and driveways.
 - Appropriate bicycle accommodations.
 - Upgrading all traffic signals to provide for standard heads and pedestrian countdown systems.
 - Installation of sidewalks where none exist.
- **WHEREAS,** in 2014, at the request of NJDOT, the City of Somers Point submitted problem statements for the intersections of Route 9 and Connecticut Avenue, Route 9 and Groveland Avenue, and Route 9 and Route 52. These problem statements provided detailed

documentation regarding unsafe conditions at these three intersections along Route 9. NJDOT has informed the City that the section of Route 9 south of Chapman Boulevard would be addressed by a future unfunded study.

- WHEREAS, a separate improvement effort is underway for the intersection of Route 9 and Somers Point-Mays Land Road and the section of Route 9 south of Somers Point-Mays Landing Road to provide a bridge connection to the Garden State Parkway bike path. A contract has been awarded to Johnson, Mirmiran & Thompson, Inc.
- **NOW, THEREFORE, BE IT RESOLVED** that the Governing Body of the City of Somers Point formally supports the NJDOT Route 9, Chapman Boulevard to Route 30 project assuming that the City's concerns and recommendations as outlined above are addressed and implemented.
- **BE IT FURTHER RESOLVED** that the Governing Body of the City of Somers Point requests that the NJDOT keep the City fully informed as the Plan moves forward and that NJDOT expedite actions to address the issues that exist on Route 9 south of Chapman Boulevard and that the Department meet with the City immediately to discuss the action plan for these safety improvements.
- **BE IT FURTHER RESOLVED** that copies of this resolution be sent to Governor Murphy, Lieutenant Governor Oliver, Senator Polistina, Assemblyman-elect Guardian, Assemblywomen-elect Swift, County Executive Levinson, County Commissioner Chairwomen Kern, and the Mayors of Absecon, Northfield, Linwood, and Pleasantville.
