Open Public Meetings Act:

Pursuant to the Open Public Meetings Act, adequate notice of this meeting has been provided to two local newspapers. The agenda has been posted at City Hall and on the City's website, somerspointgov.org.

Council President Haberkorn announced that Resolution 136 of 2025 will be pulled from tonight's agenda.

Communications:

Council President Haberkorn explained the Planning Board proposed a redevelopment plan for 90 Broadway at their last meeting. The redevelopment plan is consistent with the City's Master Plan and was passed by a vote of those present.

Mayors Report:

Mayor Tapp invited the public to attend the annual Memorial Day parade being held May 26th, at 11:00AM. The starting parade route begins at Dawes Ave. The hometown hero banners have been installed to honor veterans and active service members. Mayor Tapp reported that the Shore Road paving is postponed until Monday June 9th. Finally, he thanked the members of the Beach Concert Committee, sharing the Somers Point Beach Concert series has been awarded best outdoor concert series in the world for 2025 according to USA Today.

Administrator's Report:

None

Solicitor's Report:

Solicitor Smith reported on an agreement regarding 821 Shore Road. The City Council had entered an agreement with the owner regarding past due taxes if the property is restored within a certain time frame.

Since the owner has not made any improvements yet. The City Council agreed to ask for an update from the owner to determine the next steps. Solicitor Smith also updated the Mayor and City Council on the Beach Concert series contracts and suggested amending the contract to add another concert date, Friday September 12th, if the Council and the Police Department agree.

Council Member Johnson suggested making changes to the parking lot for safety during the Beach Concert Series. This concern will be brought to the Public Safety Committee.

Engineer's Report:

City Engineer Schneider reported the repaving work on Bala Drive is complete with a few punch list items left. He also mentioned that New Jersey Transit reached out to the city asking if they would be interested in having solar light retrofits installed at three bus stop locations. With the consent of the City Council, he will work on completing a resolution to move forward with this project.

Committee Reports:

Council Member Johnston attended the past two School Board meetings where the budget was discussed and adopted. She touched on the financial cuts they faced and believes they did the best they could after reviewing the budget herself. Johnston also thanked Shore Memorial for the generous donation given to the School Board and congratulated the hospital on the great work put into opening the new Sensory Center. Council Member Johnston recently attended the League of Municipalities Conference and wanted to bring attention to the City's website, needing to be ADA compliant by the year 2027. She suggested they start budgeting and preparing now for this lengthy process. Finally Council Member Johnston thanked the Kiwana's Club, Egg Harbor Township Key Club, Jordan Road School, and St Joseph's School for the cleaning and painting done at Somers Center Cemetery.

Council Member Owen gave an update on the upcoming events being held by the Arts Commission.

Council Member McGuigan reported that the Building and Grounds Subcommittee has advertised a request for a proposal for a Public Private Partnership Redevelopment Counsel and will keep everyone informed on the process.

An Ordinance Authorizing the Lease of Real Property Owned by the City of Somers Point to the Somers Point Police Athletic – Activities League Inc., a New Jersey 501(c)3 Non-profit Corporation

Whereas, the City of Somers Point, 1 West New Jersey Avenue, Somers Point, New Jersey (the "City") owns a building on lot 12 in block 1016, commonly known as the Eva Anderson Youth Center ("Property"); and

Whereas, the Property has been underutilized now for a period of time; and

Whereas, representatives of the City Council for the City of Somers Point ("City Council") have met with representatives of the Somers Point Athletic-Activities League, Inc. ("PAL"), for purposes of discussing terms and conditions of the lease of the Property to the PAL, subject to approval of City Council; and

Whereas, under the authority granted in the New Jersey Local Public Lands and Buildings Law and, more specifically N.J.S.A. 40A:12-14 (c) regulating leases to nonprofit corporations or associations, the City may enter into such a lease agreement upon adoption of an Ordinance; and

Whereas, City Council recognizes the benefits provided to the City through the educational and recreational programs organized and operated by PAL; and

Whereas, City Council is desirous to support the PAL by leasing to it the Property for purposes of providing it a headquarters for its operations and programs.

NOW THEREFORE, IT IS HEREBY ORDAINED by the City Council of the City of Somers Point as follows:

SECTION 1:

The Mayor of the City of Somers Point is hereby authorized to execute and deliver to the Somers Point Athletic-Activities League, Inc. a Lease, effective June 1, 2025 through December 31, 2029.

SECTION 2:

The form of Lease between the City of Somers Point and the Somers Point Athletic-Activities League, Inc., shall be substantially in the form attached hereto, and shall be subject to such modification as may be determined by the City Solicitor and City Administrator to be reasonable and necessary.

SECTION 3: During the term of the Lease the Somers Point Athletic-Activities League, Inc. shall comply with the requirements imposed upon nonprofit lessees by N.J.S. 40A:12-14(c) to annually submit a report to the City Administrator setting out the use to which the leasehold was put during each year, the activities of the lessee undertaken in furtherance of the public purpose for which the leasehold was granted; the approximate value or cost, if any, of such activities in furtherance of such purpose; and an affirmation of the continued tax-exempt status of the nonprofit corporation pursuant to both State and Federal law and that the President of the Somers Point Athletic-Activities League, Inc. and the City Administrator shall be responsible for enforcement of the conditions of the lease.

SECTION 4: All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

SECTION 5: Should any section, clause, sentence, phrase or provision or any item in any schedule of this ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.

SECTION 6: This ordinance shall take effect upon its final passage, publication and adoption in the manner prescribed by law.

AN ORDINANCE AMENDING ARTICLE V REGISTRATION AND INSPECTION OF CERTAIN RENTAL UNITS, APARTMENT UNITS AND DWELLING UNITS, CHAPTER 169-47, SUBPARAGRAPH G OF THE MUNICIPAL CODE OF THE CITY OF SOMERS POINT TO REVISE THE MINIMUM DURATION FOR SHORT-TERM RENTALS

WHEREAS, the City of Somers Point has adopted regulations governing short-term rentals in the interest of preserving the quality of life in residential neighborhoods and ensuring the public health, safety, and welfare of residents and visitors; and

WHEREAS, the City Council of the City of Somers Point has determined that increasing the minimum stay requirement for short-term rentals is necessary to further these goals and to reduce transient occupancy impacts on neighborhoods;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Somers Point, County of Atlantic, State of New Jersey, as follows:

SECTION 1

Amendment to Chapter 169-47(G):

Chapter 169, Section 47, Paragraph G of the Code of the City of Somers Point is hereby amended by deleting it in its entirety and replacing it with the following language:

§ 169-47(G)

All short-term rentals, as operating businesses, are also required to obtain a mercantile license as set forth in Chapter 174 of this Code, and in order to maintain said license, may not be rented or leased out for a time period of less than seven nights. A clear depiction of the subject's mercantile license shall be posted as a separate photo on any advertisement on a marketplace platform for the rental of the property.

SECTION 2

Repealer. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3

Severability. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision and the remainder of the ordinance shall be deemed valid and effective.

SECTION 4

Effective Date. This ordinance shall take effect upon final passage and publication as required by law.

SECTION 4: Should any section, clause, sentence, phrase or provision or any item in any schedule of this ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.

SECTION 3: This Ordinance shall take effect upon its final passage, publication and adoption in the manner prescribed by law.

WHEREAS, the City of Somers Point, in the County of Atlantic, New Jersey (the "Local Unit"), intends to undertake various stormwater improvements, including all work and costs necessary and ancillary thereto (collectively, the "Project"), and it is the desire of the Local Unit to obtain financing for such Project through participation in the New Jersey Water Bank of the New Jersey Infrastructure Bank (the "I-Bank");

WHEREAS, the Local Unit has determined to temporarily finance the undertaking of the Project prior to the closing with respect to the New Jersey Water Bank, and to undertake such temporary financing with the proceeds of a short-term loan (or loans) to be made by the I-Bank (collectively the "Construction Loan") to the Local Unit, pursuant to the Construction Financing Loan Program of the I-Bank (the "Construction Financing Loan Program");

WHEREAS, in order to (i) evidence and secure the repayment obligation of the Local Unit to the I-Bank with respect to the Construction Loan and (ii) satisfy the requirements of the Construction Financing Loan Program, it is the desire of the Local Unit to issue and sell a short term note to the I-Bank in an aggregate principal amount of up to \$4,300,000 (the "Note");

WHEREAS, it is the desire of the Local Unit to authorize, execute, attest and deliver the Note to the I-Bank pursuant to the terms of the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the Revised Statutes of the State of New Jersey (the "Local Bond Law"), and other applicable law; and

WHEREAS, on August 24, 2023 the Local Unit adopted Bond Ordinance #20-2023 (the "Local Unit Bond Ordinance") pursuant to the provisions of the Local Bond Law;

WHEREAS, Section 28 of the Local Bond Law allows for the sale of the Note to the I-Bank, without any public offering, and N.J.S.A. 58:11B-9 allows for the sale of the Note to the I-Bank without any public offering, all under the terms and conditions set forth therein.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Local Unit as follows:

- **Section 1.** In accordance with the provisions of the Local Bond Law, the Infrastructure Trust Act and the Local Unit Bond Ordinance, the Local Unit hereby authorizes the issuance, sale and award of the Note in accordance with the provisions hereof. The obligation represented by the Note have been appropriated and authorized by the Local Unit Bond Ordinance, finally adopted by the Local Unit at a meeting duly called and held on August 24, 2023, at which time a quorum was present and acted throughout, all in accordance with the Local Bond Law and other applicable law.
- **Section 2.** The Chief Financial Officer of the Local Unit (the "Chief Financial Officer") is hereby authorized to determine, pursuant to the terms and conditions hereof, (i) the final principal amount of the Note (subject to the maximum limitation set forth in Section 4(a) hereof), and (ii) the dated date of the Note.
- **Section 3.** Any determination made by the Chief Financial Officer pursuant to the terms hereof shall be conclusively evidenced by the execution and attestation of the Note by the parties authorized pursuant to Section 4(h) hereof.
- **Section 4.** The Local Unit hereby determines that certain terms of the Note shall be as follows:
 - (a) the aggregate principal amount of the Note to be issued shall be an amount not to exceed \$4,300,000;
 - (b) the maturity of the Note shall be as determined by the I-Bank;
 - (c) the interest rate of the Note shall be as determined by the I-Bank;
 - (d) the purchase price for the Note shall be par;
 - (e) the Note shall be subject to prepayment prior to its stated maturity in accordance with the terms and conditions of the Note:

- (f) the Note shall be issued in a single denomination and shall be numbered "CFP-2025-1", or other such denomination as may be requested by the I-Bank;
- (g) the Note shall be issued in fully registered form and shall be payable to the registered owner thereof as to both principal and interest in lawful money of the United States of America; and
- (h) the Note shall be executed by the manual or facsimile signatures of the Mayor and the Chief Financial Officer under official seal or facsimile thereof affixed, printed, engraved or reproduced thereon and attested by the manual signature of the Local Unit Clerk; and
- (i) the Note may be issued in one or more series as may be deemed necessary by the I-Bank.
- **Section 5.** The Note shall be substantially in the form required by the I-Bank, together with such additions, deletions and other modifications required by the I-Bank and agreed to by the Local Unit upon consultation with counsel and any advisors to the Local Unit, such determinations being conclusively evidenced by the execution of the Note by the Authorized Officers (as defined herein).
- **Section 6.** The law firm of McManimon, Scotland and Baumann, LLC is hereby authorized to arrange for the printing of the Note, which law firm may authorize McCarter & English, LLP, bond counsel to the I-Bank for the Construction Loan Financing Program, to arrange for same.
- Section 7. The Local Unit Mayor, Chief Financial Officer and Local Unit Clerk (each an "Authorized Officer") of the Local Unit are each hereby further severally authorized to (i) execute and deliver, and the Local Unit Clerk is hereby further authorized to attest to such execution and to affix the corporate seal of the Local Unit to, any document, instrument or closing certificate deemed necessary, desirable or convenient by the Authorized Officers, in their respective sole discretion, after consultation with counsel and any advisors to the Local Unit and after further consultation with the I-Bank and its representatives, agents, counsel and advisors, to be executed in connection with the issuance and sale of the Note and the participation of the Local Unit in the Construction Financing Loan Program, which determination shall be conclusively evidenced by the execution of each such certificate or other document by the party authorized hereunder to execute such certificate or other document, and (ii) perform such other actions as the Authorized Officers deem necessary, desirable or convenient in relation to the execution and delivery of the Note and the participation of the Local Unit in the Construction Financing Loan Program.
