**EMERGENCY RESOLUTION AS AUTHORIZED BY  
N.J.S.A. 40A:4-46 FOR DOWN PAYMENT ON A LOCAL  
IMPROVEMENT- SPECIAL ASSESSMENT BOND  
ORDINANCE FOR THE LAUNCH AVENUE PROJECT  
WHICH CONSISTS OF THE RECONSTRUCTION OF THE  
BULKHEAD AT LAUNCH AVENUE, THE REPAVING OF  
LAUNCH AVENUE AND THE EXTENSION OF THE  
WATER DISTRIBUTION SYSTEM ON LAUNCH AVENUE**

**WHEREAS**, an emergency has arisen with respect to the need to fund a local capital improvement authorization for the City of Somers Point, County of Atlantic, State of New Jersey to complete the Launch Avenue Project which consists of the reconstruction of the bulkhead at Launch Avenue, repaving Launch Avenue and the extension of the water distribution system on Launch Avenue and the City desires to adopt a special assessment bond ordinance appropriating the sum of \$750,000 to finance the cost of such improvements; and

**WHEREAS**, the sum of \$37,500 is the amount of the down payment in the bond ordinance for the project as required pursuant to N.J.S.A. 40A:2-11, which down payment is required to be available by virtue of provision in a previously adopted budget or budgets of the City for down payment for capital improvement purposes; and

**WHEREAS**, no adequate provision was made in the 2018 budget for the aforesaid purpose as these improvements were unforeseen at the time of adoption of such budget, and N.J.S.A. 40A:4-46 provides for the creation of an emergency appropriation for the purpose mentioned above; and

**WHEREAS**, the total amount of the emergency appropriations created, including the appropriation to be created by this Resolution, is \$37,500, and three (3%) percent of the total operating appropriations in the budget for 2018 is \$428,753.27; and

**WHEREAS**, the foregoing appropriation together with prior appropriations does not exceed three (3%) percent of the total operating appropriations (including utility operation appropriations) in the budget for 2018.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOMERS POINT, IN THE COUNTY OF ATLANTIC, NEW JERSEY** (with the affirmative concurrence of not less than two-thirds of all the members thereof), **AS FOLLOWS:**

1. An emergency appropriation is hereby made for the down payment required in the special assessment bond ordinance for the Launch Avenue Project in the amount of \$37,500.00.

2. Said emergency appropriation shall be provided for in full in the 2019 budget, and is requested to be excluded from CAPS, pursuant to N.J.S.A. 40A:4:53.3 c(1).

4. Two (2) certified copies of this Resolution shall be filed with the Director of the Division of Local Government Services.
5. This Resolution shall take effect immediately upon adoption, this 23rd day of August, 2018.



**WHEREAS**, it is the City’s intention to eliminate or substantially minimize situations where there are blockages or spills from the sanitary sewer system due to devices that are not functioning properly; and

**WHEREAS**, the Somers Point Sewer Utility recognizes that changes to the policies and procedures that relate to Grease Traps, Interceptors and other Pretreatment Devices connected to the Somers Point Sewer System may substantially reduce fats, oils, and grease effluents in the system;

  - (3) All existing Federal, State, County and Municipal laws, statutes, ordinances, rules and regulations including, by way of description and not by limitation, existing zoning, health and planning board rules and regulations.
  - (4) No representation of any kind is made that the land, in question, surface as well as subterranean portions, is suitable or adaptable for any particular use whatsoever.
  - (5) No representation of any kind is made concerning gas or electric service to the land.

(d) In the event that the City cannot convey good and marketable title, subject to the above, the purchaser will be entitled to the return of the deposit, without interest, and the City will not be responsible or liable in any other manner and for any other amount.

(e) In the event that the purchaser defaults in making payment to the City, as set forth above, or if the purchaser cannot make settlement in accordance with the terms thereof, the deposit made by the successful bidder on account of the purchaser will be retained by the City as and for its liquidated damages, and the land may be resold. This remedy shall be in addition to the City's right to compel specific performance of the purchaser's obligation hereunder. Time is of the essence.

(f) That the purchaser, for himself, his heirs, personal representative, successors and assigns, waives any possible exemption from taxes and assessments, and interest and other lawful charges thereon by reason of the ownership of the premises by the City of Somers Point prior to sale, and that the said premises shall be liable for and subject to the same manner and under and subject to all lawful charges thereon, as well as the tax liens and tax sale, as real estate not municipally owned.

(g) No bids shall be accepted from any owner of property in the City of Somers Point for which any real estate taxes or municipal charges are due and unpaid at the time of sale.

(h) The Deed shall contain the condition and agreement by Buyer and Seller that the purchase price of the property or any information involved in its determination shall not be used as evidence in any appeal of municipal taxes for this or any other property.

**A LOCAL IMPROVEMENT-SPECIAL ASSESSMENT BOND ORDINANCE PROVIDING FOR THE REPLACEMENT OF THE BULKHEAD, STREET REPAVING AND INSTALLATION OF NEW WATER MAIN AND RELATED APPURTENANCES ON LAUNCH AVENUE, IN AND BY THE CITY OF SOMERS POINT, IN THE COUNTY OF ATLANTIC, NEW JERSEY, APPROPRIATING \$750,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$712,500 ASSESSMENT BONDS AND NOTES OF THE CITY TO FINANCE PART OF THE COST THEREOF AND DIRECTING THE SPECIAL ASSESSMENT OF THE COST THEREOF**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SOMERS POINT,  
IN THE COUNTY OF ATLANTIC, NEW JERSEY (not less than two-thirds of all  
members thereof affirmatively concurring) AS FOLLOWS:**

**SECTION 1. Appropriation for Project – Down Payment.**

The improvements described in Section 3(a) of this bond ordinance are hereby authorized to be undertaken by the City of Somers Point, Atlantic County, New Jersey (the “City”) as local improvements. For the improvements or purposes described in Section 3(a), there is hereby appropriated the sum of \$750,000, including the sum of \$37,500 as the down payment required the Local Bond Law of New Jersey *N.J.S.A. 40A:2-1*, et seq. (the “Local Bond Law”). The down payment is now available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

**SECTION 2. Authorization of Bonds and Notes.**

In order to finance the cost of the improvements or purposes not covered by application of the down payment, negotiable bonds are hereby authorized to be issued in the principal amount of \$712,500 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued in the principal amount of \$712,500, pursuant to and within the limitations prescribed by the Local Bond Law.

**SECTION 3. Description of Project.**

(a) The several improvements hereby authorized and the several purposes of the financing for which the bonds are to be issued consist of the construction of new replacement bulkhead, repaving and reconstruction of Launch Avenue, installation of a new water main, together with all related improvements, appurtenances, work and equipment as required to repair this deteriorated infrastructure and protect the public health, safety and welfare.

(b) The estimated maximum amount of bonds or notes to be issued for the improvements or purposes is as stated in Section 2 hereof.

(c) The properties affected or specially benefited by the several improvements are identified on the Tax Map of the City of Somers Point as listed on **Attachment A** of this bond ordinance, which list is for informational purposes and is subject to change.

(c) The estimated costs of the improvements or purposes are equal to the amount of the appropriation herein made therefor.

(d) The aggregate estimated costs of the improvements or purposes to be specially assessed against the real estate which is to be specially benefited thereby are \$750,000.

**SECTION 4. Issuance of Notes.**

All bond anticipation notes issued hereunder shall mature at such times as may be determined by the City's Chief Financial Officer; provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the Chief Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of *N.J.S.A. 40A:2-8(a)*. The Chief Financial Officer is hereby authorized to sell part or all of the notes from time to time, at not less than par and accrued interest, at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this ordinance is made. Such report shall include the amount, the description, the interest rate and the maturity scheduled of the notes sold, the price obtained and the name of the purchaser.

**SECTION 5. Capital Budget.**

The capital budget of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

**SECTION 6. Special Assessment Notice.**

(a) Notice is hereby given to the owners of all lots and parcels of real estate benefited by the improvements described in Section 3(a) hereof and affected by the improvements described herein that the City of Somers Point intends to make and levy special assessments against all such lots and parcels of real estate in an aggregate maximum amount not exceeding \$750,000. Such special assessments shall be made and levied in the manner provided by law and shall be as nearly as possible in proportion to and not in excess of the peculiar benefit, advantage or increase in value that the respective lots and parcels of real estate shall be deemed to receive by reason of the improvements.

(b) If the amount of the special assessments as finally confirmed is less than \$750,000, then the City will contribute the difference between such reduced special

assessments and the cost of the improvements, such difference to be financed by the issuance of general improvement bonds or notes of the City.

**SECTION 7. Additional Matters.**

(a) The owner of any land upon which an assessment for the local improvements shall have been made may pay such assessment in the number of equal yearly installments determined herein with legal interest on the unpaid balance of the assessment. The first of such installments shall be due and payable two (2) months after the confirmation of the assessment, and each subsequent annual installment and interest shall be payable in each successive year at such time as the governing body shall by resolution determine, provided that any owner of land so assessed shall have the privilege of paying the whole of any assessment or any balance of installments with accrued interest thereon at one time. In case any such installment shall remain unpaid for thirty (30) days after the time it shall become due and payable, the whole assessment or the balance thereof shall become and be immediately due and payable, shall draw interest at the rate imposed upon the arrearage of taxes in the City and shall be collected in the same manner as provided by law for other past due assessments. Such assessment shall remain a lien upon the land described herein until the assessment, with all installments and accrued interest thereon, shall be paid and satisfied. Notwithstanding anything herein to the contrary, the City shall have the right to waive default as many be permitted by law.

(b) The purposes described in Section 3(a) of this bond ordinance are not current expenses. They are improvements that the City may lawfully undertake as local improvements, the cost of which shall be specially assessed on property specially benefited thereby.

(c) The period of usefulness of the improvements or purposes within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this bond ordinance, is eighteen (18) years.

(d) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the Office of the City Clerk, and a complete executed duplicate thereof has been electronically filed in the Office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement above shows that the gross debt of the City as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$712,500 and the obligations authorized herein will be within all debt limitations prescribed by that law.

(e) An aggregate amount not exceeding \$115,000 for items of expense listed in and permitted under *N.J.S.A. 40A:2-20* is included in the estimated cost indicated herein for the purposes or improvements.

(f) The number of annual installments within which the special assessments are to be levied on the lots and parcels of real estate benefited by the improvements is

eighteen (18) years or the period for which bonds are issued for the improvements authorized by this bond ordinance, whichever shall be less.

**SECTION 8. Application of Grants.**

Any grant monies received for the purposes described in Section 3(a) hereof shall be applied to reduce the general obligations of the City incurred in connection with the cost of the improvements. When and if such obligations shall be completely retired, any additional monies received shall be applied to reduce the obligations of the specially assessed property owners. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such monies are so used.

**SECTION 9. Official Intent to Reimburse Expenditures.**

The City reasonably expects to reimburse any expenditures towards the costs of the improvements or purposes described in Section 3 of this ordinance and paid prior to the issuance of any bonds or notes authorized by this ordinance with the proceeds of such bonds and notes. No funds from sources other than the bonds or notes authorized herein has been or is reasonably expected to be reserved, allocated on a long-term basis or otherwise set aside by the City, or any member of the same “control group” as the City, within the meaning of Treasury Regulations Section 1.150-1(f), pursuant to their budget or financial policies with respect to any expenditures to be reimbursed. This Section is intended to be and hereby is a declaration of the City’s official intent to reimburse any expenditures towards the costs of the improvements or purposes described in Section 3 hereof to be incurred and paid prior to the issuance of bonds or notes authorized herein in accordance with the Treasury Regulations Section 1.103-18, and no action (or inaction) will be an artifice or devise in accordance with Treasury Regulation Section yield restrictions or arbitrage rebate requirements.

**SECTION 10. Full Faith and Credit.**

The full faith and credit of the City are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the City, and the City shall be obligated

to levy *ad valorem* taxes upon all the taxable real property within the City for the payment of the obligations and the interest thereon without limitation as to rate or amount.

**SECTION 11. Tax Covenant.**

The City hereby covenants as follows:

(a) it shall take all actions necessary to ensure that the interest paid on the bonds or bond anticipation notes authorized by the bond ordinance is exempt from the gross income of the owners thereof for federal income taxation purposes, and will not become a specific item of tax preference pursuant to Section 57(a)(5) of the Internal Revenue Code of 1986, as amended (the "Code");

(b) it will not make any use of the proceeds of the bonds or bond anticipation notes to be "arbitrage bonds" as such term is defined in Section 148(a) of the Code and the Regulations promulgated thereunder;

(c) it shall calculate or cause to be calculated and pay, when due, the rebatable arbitrage with respect to the "gross proceeds" (as such term is used in Section 148(f) of the Code) of the bonds or bond anticipation notes;

(d) it shall timely file with the Internal Revenue Service, such information report or reports as may be required by Sections 148(f) and 149(e) of the Code; and

(e) it shall take no action that would cause the bonds or bond anticipation notes to be "federally guaranteed" within the meaning of Section 149(b) of the Code.

**SECTION 12. Ratification of Prior Acts**

Any action taken by any officials of the City in connection with the improvements described in Section 3 hereof are hereby ratified and confirmed notwithstanding that such actions may have been taken prior to the effective date of this bond ordinance and shall be deemed to have been taken pursuant to this bond ordinance.

Be it ordained by the City Council of the City of Somers Point that Chapter 216 of the Code of the City of Somers Point is hereby amended to add Article III entitled, “Improper Disposal of Waste Into the Stormwater System,” as follows:

SECTION I. Purpose:

An ordinance to prohibit the spilling, dumping, or disposal of materials other than stormwater into the municipal separate storm sewer system (MS4) operated by the City of Somers Point, so as to protect public health, safety and welfare, and to prescribe penalties for the failure to comply.

SECTION II. Definitions:

For the purpose of this ordinance, the following terms, phrases, words, and their derivations shall have the meanings stated herein unless their use in the text of this Chapter clearly demonstrates a different meaning. When not inconsistent with the context, words used in the present tense include the future, words used in the plural number include the singular number, and words used in the singular number include the plural number. The word “shall” is always mandatory and not merely directory.

- a. Municipal separate storm sewer system (MS4)– a conveyance or system of conveyances (including roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, manmade channels, or storm drains) that is owned or operated by City of Somers Point or other public body, and is designed and used for collecting and conveying stormwater.
- b. Person – any individual, corporation, company, partnership, firm, association, or political subdivision of this State subject to municipal jurisdiction.
- c. Stormwater – water resulting from precipitation (including rain and snow) that runs off the land’s surface, is transmitted to the subsurface, is captured by separate storm sewers or other sewerage or drainage facilities, or is conveyed by snow removal equipment.

### SECTION III. Prohibited Conduct:

In addition to any prohibitions delineated elsewhere in this Chapter, the spilling, dumping, or disposal of materials other than stormwater into the municipal separate storm sewer system operated by City of Somers Point is prohibited. The spilling, dumping, or disposal of materials other than stormwater in such a manner as to cause the discharge of pollutants into the municipal separate storm sewer system is also prohibited.

### SECTION IV. Exceptions to Prohibition:

- a. Water line flushing and discharges from potable water sources, but limited, however, to the capacity of the MS4 system and not to cause flooding of any public or private property or street, boulevard, avenue, road, highway, cul-de-sac, alley or other area of public travel
- b. Uncontaminated ground water (e.g., infiltration, crawl space or basement sump pumps, foundation or footing drains, rising ground waters)
- c. Air conditioning condensate (excluding contact and non-contact cooling water)
- d. Irrigation water (including landscape and lawn watering runoff)
- e. Flows from springs, riparian habitats and wetlands, water reservoir discharges and diverted stream flows
- f. Residential car washing water, and residential swimming pool discharges
- g. Sidewalk, driveway and street wash water
- h. Flows from fire fighting activities
- i. Flows from rinsing of the following equipment with clean water:

- Beach maintenance equipment immediately following their use for their intended purposes; and
- Equipment used in the application of salt and de-icing materials immediately following salt and de-icing material applications. Prior to rinsing with clean

water, all residual salt and de-icing materials must be removed from equipment and vehicles to the maximum extent practicable using dry cleaning methods (e.g., shoveling and sweeping). Recovered materials are to be returned to storage for reuse or properly discarded.

Rinsing of equipment, as noted in the above situation is limited to exterior, undercarriage, and exposed parts and does not apply to engines or other enclosed machinery.

**SECTION V. Enforcement:**

This ordinance shall be enforced by the Code Enforcement Official of City of Somers Point.

**SECTION VI. Penalties:**

Any person(s) who continues to be in violation of the provisions of this ordinance, after being duly notified, shall be subject to a fine as set forth in § 216-2.

**SECTION VII. Severability:**

Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

**SECTION VIII. Effective date:**

This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.

**WHEREAS**, a request has been made by Mr. John J. Cooney, Jr., stating the need for a Handicapped Parking Space for his benefit on and within Groveland Avenue, the City street which fronts his 40 Chapman Boulevard, Apartment H-8 residence, Somers Point, NJ; and

**WHEREAS**, the request did include both the required verified Permanent Disability Parking Placard and Person With A Disability ID issued by the New Jersey Motor Vehicle Commission; and
