- 3. N.J.S.A. 54:6-67 specifically provides that a governing body may fix a penalty to be charged to a taxpayer where there is a tax and/or other municipal charge delinquency in excess of \$10,000.00 at the end of any calendar year on a given parcel of real estate; and
- 4. That a penalty equal to six percent of the amount of any delinquency in taxes and other municipal charges on a given parcel of real property shall be and is hereby imposed where the delinquency exceeds \$10,000.00 at the end of each calendar year.

WHEREAS, under this act if aggravated sexual assault is committed on a victim under the age of 18 the actor would be punishable by a mandatory term of imprisonments of 25 years to life; and

WHEREAS, this act creates the new crime of first degree sexual assault where the victim is less than 18 years of age and an offense is committed under specific circumstances the person convicted of said crime would be sentenced to a term of between 25 years to life of which the convicted must serve 25 years before being eligible for parole; and

WHEREAS, this act provides for mandatory term of imprisonment of three years without eligibility for parole if an actor harbored or concealed a person who is the subject to the registration requirements of Megan's Law and who the actor has reason to believe is not complying or has not complied with the Megan's Law registration process.

NOW THEREFORE, BE IT RESOLVED, that the governing body of the City of Somers Point calls on its elected representatives in Trenton, Senator Jefferson Van Drew and Assembly members Nelson Albano and Mathew Milam, to work with their colleagues in the Legislature and with their Governor to take affirmative action to pass these bills and have the "Jessica Lunsford Act" made in to law for the State of New Jersey.

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded to Governor Chris Christie, Senator Jefferson Van Drew and Assembly members Nelson Albano and Mathew Milam, and to the New Jersey State League of Municipalities.
