WHEREAS, it is necessary to schedule and hold a Special Emergency Meeting; and
WHEREAS, as permitted by NJS 10:4-9 upon the affirmative vote of three quarters of the members present a public body may hold a meeting notwithstanding the failure to provide adequate notice if:

(1) such meeting is required in order to deal with matters of such urgency and importance that a delay for the purpose of providing adequate notice would be likely to result in substantial harm to the public interest; and

(2) the meeting is limited to discussion of and acting with respect to such matters of urgency and importance; and

(3) notice of such meeting is provided as soon as possible following the calling of such meeting by posting written notice of the same in a public place and also by notifying two newspapers designated by City Council to receive such notice by telephone, telegram, or by delivering a written notice of same to such newspapers; and

(4) the public body could not reasonably have foreseen the need for such meeting at a time when adequate notice could have been provided; and

WHEREAS, the notice provision required by statute has been complied with subject to adoption of this resolution.

NOW THEREFORE BE IT RESOLVED, by an affirmative vote of not less than three – quarters (3/4) of the members present that the City Council of the City of Somers Point do hereby authorize this Special Emergency Meeting to be held at 5:30 p.m. on this 30th day of March, 2023 for the limited purpose of considering and acting upon a Person to Person Transfer of plenary retail consumption liquor license No. 0121-33-002-003 from RJM Enterprises, Inc., t/a Anchorage Tavern Restaurant to MPF741LLC LLC resolution, and for no other purpose.

WHEREAS a New Jersey Tax Clearance Certificate, Application for Bulk Sale Permit, Consent to Transfer along with proof of publication of the Notice of Pending Application published in The Press of Atlantic City on February 6 and February 13, 2023, have been filed with the Somers Point City Clerk; and

NOW, THEREFORE BE IT RESOLVED that the Governing Body of the City of Somers Point, Atlantic County, New Jersey, does hereby approve, effective March 30, 2023, the transfer of New Jersey Alcoholic Beverage Control Plenary Retail Consumption License 0121-33-002-003 from RJM Enterprises, Inc., to MPF741LLC LLC, and does hereby direct the City Clerk to endorse the License certificate to the new ownership as follows:
