SECTION 1. STATEMENT OF INTENT AND PURPOSE.

WHEREAS, the City of Somers Point applied for and received from the New Jersey Department of Transportation a National Boating Infrastructure Grant (NBIG) in the amount of \$1,448,449 to fund a portion of a Transient Marina on the site of the Higbee Pier to accommodate boaters travelling north and south along the Inter - Coastal Waterway; and

WHEREAS, the City of Somers Point applied for and received a National Fish and Wildlife Foundation Grant to partially fund the dredging of that portion of Great Egg Harbor Bay adjacent to City owned property; and

WHEREAS, dredging of the shipping channel within the bay is essential to the transient marina; and

WHEREAS, the Angelou Economics Report prepared on behalf of the County of Atlantic recognized the need for the County and each municipality within the County to identify projects and initiatives to successfully migrate reliance upon casino gaming to a more robust and viable economy based upon tourism, technology, education and healthcare; and

WHEREAS, the City through its Economic Development Committee, Arts Commission, Green Team and other efforts has diligently pursued opportunities to improve the economy of the City and the rejuvenation and revitalization of the Bay Avenue area; and

WHEREAS, the dredging grant requires an environmental enhancement utilizing the dredge materials; and

by Resolution 183 of 2014 adopted on October 23, 2014 the Somers Point City Council accepted the recommendation of the Somers Point Planning Board and designated the area consisting of Block 1114, Lots 3, 4.01, 4.02, 4.03 and 4.04 as a non-condemnation area in need of redevelopment (the Redevelopment Area); and

Whereas, by Ordinance 5 of 2015 adopted on February 26, 2015 a Redevelopment Plan for Bayview Court (the "Redevelopment Project") was approved and adopted; and

Whereas, by Resolution 61 of 2016 adopted on February 25, 2016 Bayview Court Urban Renewal Entity, LLC was designated as the Redeveloper for the Redevelopment Area and the execution and delivery of a Redevelopment Agreement (the "Redevelopment Agreement") between the City of Somers Point and Bayview Court Urban Renewal Entity, LLC was approved and authorized which incorporated the Redevelopment Plan; and

Whereas, on March 24, 2016 by Ordinance 2 of 2016 a Long Term Tax Exemption and Capital Contribution Agreement (the "Long Term Agreement") was authorized to be entered into between the City of Somers Point (the "City") and Bayview Court Urban Renewal Entity, LLC (the "Redeveloper"); and

Whereas, the Redeveloper has diligently pursued the Redevelopment Project as contemplated by the Redevelopment Plan; and

Whereas, due to circumstances beyond the control of the Redeveloper including, but not limited to, relocation of tenants to rehabilitate and improve the individual units as specified in the Redevelopment Plan, increased capital costs due to structural conditions which needed to be addressed but which were not evident until the Redevelopment Project had commenced, phasing in of the improvements, and other necessities, the construction schedule which had been originally submitted, has been delayed; and

Whereas, as a result, although the budget submitted by the Redeveloper has been significantly exceeded, the Redeveloper is absorbing the additional cost and is not requesting any additional capital contribution from the City; and

Whereas, as a result of the unforeseen delays and cost increases which necessitated Redeveloper obtaining additional financing, the Redeveloper has submitted a request that the City Council amend the construction schedule which had been included as Exhibit D to the Long Term Agreement and the Redevelopment Agreement granting an extension of time for achieving Substantial Completion, modifying the dates for completion of certain of the Redevelopment Project elements, increasing the number of competed units to achieve substantial completion, and extending the date of final completion of the entire Redevelopment Project until June 30, 2029; and

Whereas, this governing body, the Code Enforcement Officer and the City Administrator have reviewed the scope of work completed to date, the annual certified audit and other financial details submitted to the City as required by the Redevelopment and Long Term Agreements, and has taken into consideration the achievement of the Redeveloper in vastly improving the property but also the beneficial improvement to the entire neighborhood for which Redeveloper has been nominated by the New Jersey Apartments Association and the 2017 Garden States Award Committee as a finalist and won the award for the Bayview Court Exterior Visual Restoration / Curb appeal and Management; and

Whereas, the requested amendment will not result in any incremental cost to the City; and

Whereas, this governing body has determined that it is in the best interest of the City, the Redeveloper, and the community to grant the requested amendment.

Now, therefore, it is hereby Ordained by the City Council of the City of Somers Point, County of Atlantic, State of New Jersey that the Mayor is authorized to execute and the City Clerk is authorized to witness and deliver a First Amendment to the Long Term Tax Exemption and Capital Contribution Agreement between the City of Somers Point and. SUPPORTING S2872 AND A4510 CREATING CERTAIN INCENTIVES TO QUALIFIED BUSINESSES IN GARDEN STATE GROWTH ZONE IN ATLANTIC CITY AND

CREATING A GARDEN STATE GROWTH ZONE AT THE FAA WILLIAM J. HUGHES CENTER AND SURROUNDING AREA

WHEREAS, the State of New Jersey provides incentives to qualified businesses under the Grow New Jersey Assistance Program and Economic Redevelopment and Growth Grant Program for businesses located in the Garden State Growth Zone and enhanced incentives available only to businesses located in the Garden State Growth Zone in Camden; and

WHEREAS, to provide incentives for economic growth in the Atlantic City region the late Senator Whelan introduced Senate Bill 2872; and

WHEREAS, this legislation to all the Garden State Growth Zones in Atlantic City, Passaic, Paterson and Trenton; and

WHEREAS, this legislation creates a Garden State Growth Zone within an "aviation district," meaning all areas within the boundaries of the Atlantic City International Airport and the Federal Aviation Administration William J. Hughes Technical Center, and the area within a one-mile radius of the outermost boundary of that airport and technical center and adds to the definition of an Urban Transit Hub any property within a one mile radius from the mid-point of a NJ Transit rail station platform if the platform is within a Garden State Growth Zone.; and

WHEREAS, the legislation provides enhanced incentives to qualified businesses within the newly created Garden State Growth Zone which were only available to qualified businesses within the Camden Garden State Growth Zone; and

WHEREAS, the Atlantic City region has witnessed significant economic decline resulting in a reduction of the Atlantic City ratable base from \$20.3 billion in 2009 to \$6.5 billion in 2016; a declining labor force from 142,000 in 2010 to 123,000 in 2016; a high unemployment rate of 7.2 percent compared to 4.8 percent Statewide and the highest foreclosure rate in the nation; and

WHEREAS, the Atlantic County Economic Development Strategy and Action Plan provides guidance for the region's economic recovery stresses the need for diversification; and

WHEREAS, the Action Plan stresses the regions leverageable assets including the FAA William J. Hughes Technical Center, Stockton University, proximity to major markets and affordability; and

WHEREAS, the FAA William J. Hughes Technical Center is the nation's premier air transportation system laboratory; and

WHEREAS, aviation-related assets at the FAA William J. Hughes Technical Center and Atlantic City International Airport can foster training, technology and service-related growth industries including drone technology and testing; and

WHEREAS, technology programs at local universities coupled with EDA incentives would create incubators for growth; and

WHEREAS, with the Stockton Aviation Research & Technology Park construction underway, these incentives will serve to attract new businesses to the region, provide employment and expand the economy of the region; and

WHEREAS, many properties have been identified in Atlantic City that are served by all utilities and development ready; however, enhanced incentives are needed to attract new companies to the region; and

WHEREAS, the governing body of the City of Somers Point has enacted various ordinances, has applied for and received various grants, and through its Economic Development Advisory Committee and other Committees and Boards has taken actions to increase economic, business, and residential growth; and

WHEREAS, enactment of this legislation will provide further future benefits not only to the County and the region but also to the City of Somers Point through increased development and employment

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the City of Somers Point call on the elected officials of New Jersey to adopt and sign into law S2872 to stimulate the economic recovery and diversification of Atlantic County and our entire region.
