Whereas, the Southbound Span of the Garden State Parkway includes a pedestrian walkway / bike path linking Somers Point and Upper Township and points north; and

Whereas, the Somers Point - Ocean City Rt. 52 Bridge includes a pedestrian walkway / bike path linking Somers Point and Ocean City; and

Whereas, the City of Somers Point is in the process of extending the Somers Point Bike Path to connect to Rt. 52, Rt. 559 and the Somers Point - Ocean City Bridge; and

Whereas, there is no existing adequate pedestrian walkway / bike path linking the Somers Point Bike Path, the Rt. 52 Bridge pedestrian walkway / bike path and the Garden State Parkway Bridge pedestrian walkway / bike path; and

Whereas, representatives of the New Jersey Turnpike Authority, the New Jersey Department of Transportation, Atlantic County and Somers Point have worked together to develop a plan to connect the Garden State Parkway Bridge pedestrian walkway / bike path to Route 9, the Somers Point - Mays Landing Road (CR559), Route 52, the Somers Point - Ocean City pedestrian walkway / bike path and the Somers Point Bike Path which, if constructed, will provide a safe and scenic route providing connectivity to the system of bike paths and bike routes within the State; and

Whereas, the proposed plan which is in the concept phase will require the construction of an overpass across the Northbound Parkway Exit Ramp connecting to the east side of the Exit Ramp, continuing along the East side of Rt. 9 to the intersection of Rt. 9 and Somers Point - Mays Landing Road (CR 559) and then along the South Side of CR559 to the Somers Point - Ocean City Bridge; and

Whereas, the New Jersey Department of Transportation and Parsons Brinkerhoff have requested a Resolution of Support for the project from City Council in order to move the project into the engineering, design, and cost determination phase in anticipation of being able to undertake the construction while the construction of the Northbound Parkway Bridge Span is continuing; and

Whereas, City Council and the City Engineer have reviewed the concept plan and project summary: and

Whereas, City Council is submitting a grant application to the NJ Department of Transportation requesting funding for the pedestrian walkway / bike path to be constructed along CR 559; and

Whereas, the City Council believes that a safe connection of pedestrian walkways / bike paths is beneficial to the City, its residents, businesses and visitors

**Old Business**

Councilman Smith indicated that the Recreation Commission would be able to prepare a proper budget if they knew the status of the City accepting the Route 52 Corridor Project (Project). In addition, Councilman Smith recommended an option of going out to bid for the maintenance of Route 52. Attorney Franklin advised that if the City were to accept the Project, the boat ramp could fall under the Recreation Commission. Wes Swain, City Administrator, advised that the City would not own the property, but be responsible for the upkeep and boat ramp fees collected must be used for the upkeep. City Administrator Swain explained that the New Jersey Department of Transportation (NJDOT) had planned a walk-through of where all the processes were located and would provide the City with pieces of the lights and sprinkler heads; but the NJDOT never followed through. There has been difficulty locating the contact person from the NJDOT. Additionally, it is his understanding that there should be a meeting before the City assumes responsibility and control of the property. For the past three years, the City has maintained the property. Mr. Swain recommended collecting fees and hiring a boat ramp attendant to monitor the area. Councilman Smith opined that the City has accepted responsibility of the area by acknowledging that the NJDOT is not coming back for a meeting, and the City has been maintaining the areas. City Council President McGuigan announced that the City has accepted the Project. A letter will be forwarded to NJDOT notifying them that Somers Point has accepted the Project.

Council President McGuigan mentioned that asphalt was replaced at the Rt. 52 instead of the brick overlay. Mr. Schneider will contact the NJDOT for the proper in-kind replacement.

## **New Business:**

### Proposed Ordinance for Bus Stop

Council President McGuigan mentioned that the ordinance will be on the February 9, 2017, agenda.

### Proposed Ordinance Regarding Four Way Stop Intersection

Councilman Toto reported that there have been complaints from residents at the intersection of Ambler Road and Bala Avenue. He mentioned that a four way stop would help reduce the amount of accidents and slow down the traffic in that area. Councilman Smith opposed the four way stop proposal because this area doesn't have many four way stops as does the Midwest, and everyone believes their road is the most dangerous. Council President McGuigan mentioned that he would request additional information from the Police Department. Councilman Dill shared the four way stop history of Massachusetts Avenue and Ambler Road, which was a through street. Then the road was reconstructed and vehicles kept hitting the drainage ditch, which was a public safety issue. It was more economical to make that intersection a four way stop than reconstructing the whole intersection. Since the National Highway Safety Administration historically has not been a proponent of four way stop intersections, Mayor Glasser recommended doing more research. The Governing Body discussed receiving any accident reports and additional information from the Police Department.

Mr. Chris residing at 401 Ocean Heights Road congratulated Somers Point regarding our rating with Standard and Poor. Additionally, he questioned his water quality, and City Council President referred him to the New Jersey American Water Company.

Mr. Himmelstein of Surfside Casual expressed his concerns regarding Braddock Avenue and curbing and sidewalks and requested City Council to vacate a portion of Braddock Avenue. City Council President McGuigan referred the matter to the Parking and Traffic Committee.

Mr. Michael Caserta residing at 138 Decatur Avenue expressed his concerns regarding flooding. Councilman Gerety questioned City Engineer, Greg Schneider, regarding the check valve. Mr. Schneider indicated that the check valve is fairly old and may need replacement. Council President McGuigan stated that Mr. Schneider will inspect the area. Mr. Caserta thanked everyone for their assistance.

Mr. Franco agreed with Mr. Caserta with his concerns. Council President McGuigan assured Mr. Franco that the City's emergency services will do everything in their power to safeguard residents and property.
