WHEREAS, the New Jersey Legislature enacted the Common Sense Shared Services Pilot Program Act codified as N.J.S. 40A:65-1 et seq. and declared in N.J.S. 40A:65-13 that it is the intent of the Legislature to facilitate and promote shared service agreements, and therefore the grant of power under sections 1 through 35 of P.L.2007, c.63 (C.40A:65-1 through C.40A:65-35) (the "Act") is intended to be as broad as is consistent with general law; and

WHEREAS, in N.J.S. 40A:65-4 the Act specifies that any local unit may enter into an agreement with any other local unit or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive within its own jurisdiction, including services incidental to the primary purposes of any of the participating local units including services from licensed or certified professionals required by statute to be appointed; and

WHEREAS, the Mayor and City Council have encouraged the examination of areas of municipal operations which may be appropriate for the sharing of services; and

WHEREAS, the City Tax Assessor has identified an opportunity to enter into a Shared Service Affiliate Intern Credit Agreement with Stockton University under the jurisdiction of that office which will enable one or more Stockton University degree candidates the opportunity to earn class credits and experience related to their course of study and which will impose no cost upon the City and its taxpayers; and

WHEREAS, Stockton University and the City of Somers Point are local units within the meaning of the Act; and

WHEREAS, the form of Agreement has been reviewed by the City Solicitor, City Administrator, and City Tax Assessor and has been determined to be acceptable

Now, therefore, it is hereby **RESOLVED** that the Mayor of the City of Somers Point is authorized to execute and deliver the Shared Service Intern Credit Affiliate Agreement between the City of Somers Point and Stockton University (the "Agreement") in the form attached hereto; and

It is further **Resolved** that this governing body accepts and approves the offer of Diane Hesley to serve as the Affiliate Representative and Faculty Liaison as contemplated by the terms of the Agreement.

Consent Agenda

There were no items on the consent agenda.

Old Business

Councilman Tapp advised that Mr. Bartholomew came before them recently requesting that we vacate a portion of the Right of Way and we had asked Atty. Franklin to look into this. Atty. Franklin stated that in order to proceed we would need an escrow to be posted for \$1000.00 with Administrator Swain. Mr. Bartholomew stated that he would be willing to post a bond or pay for the title search. Atty.
