2. Completed working a test period (or the equivalent of a non civil service municipality);

3. Was not a Special or Seasonal Officer; and

4. Was laid off for reasons of economy within the preceding sixty (60) months; and

WHEREAS, proceeding to fill the vacancies from the Rice List will result in an economic saving to the City of Somers Point and its citizens by eliminating the need for a course of training at the New Jersey State Police Academy, will allow the patrol officers to be promptly assigned to duty on the streets of Somers Point without delay, and will enhance the public safety of this City, its residents and its visitors; and
