## **City Administrator Report**

Wes Swain, Administrator, explained the benefit to belonging to the FEMA Community Rating System, which may help taxpayers receive reductions to their flood insurance premiums. # NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SOMERS POINT, IN THE COUNTY OF ATLANTIC, NEW JERSEY AS FOLLOWS:

## Section 1. REPEAL OF A PORTION OF SUBPARAGRAPH A. OF SECTION 220-11.

The first paragraph of subparagraph A. in Code Section 220-11 "Permit Required" is deleted in its entirety.

# **Section 2.** AMENDMENT OF SECTION 220-11 TO REPLACE THE FIRST PARAGRAPH OF SUBPARAGRAPH A. OF SECTION 220-11.

Code Section 220-11 "Permit Required" is amended to add a new first paragraph in subparagraph A. to read as follows:

A. It shall be unlawful, except in an emergency as set forth in Subsection B and for the exempted activities set forth in Subsection F hereunder, for any person to engage in any of the following activities unless such person shall first have obtained the applicable Street Opening / Closure / Detour Permit from the City Clerk as herein provided:

### Section 3. AMENDMENT OF SECTION 220-11 TO ADD SUBPARAGRAPH F.

Code Section 220-11 "Permit Required" is amended to add a new Section 220-11. F. to read as follows:

- F. **Exemptions.** No street opening permit shall be required for:
  - i) the repair or replacement of residential sidewalks; and

- ii) the repair or replacement of residential driveways and driveway aprons along with associated curbing, provided the curb along the driveway apron to be replaced is twenty (20') feet in length or less; and
- iii) in each such instance a valid construction permit is obtained from the Construction Official. A valid certificate of insurance, meeting the requirements of Section 220-16 are still required.

Property owners completing the work themselves shall provide a copy of proof of homeowner's insurance along with a completed Hold Harmless Agreement to indemnify and hold harmless the City, its agents, servants and employees from any and all damage or liability sustained by any person, including injury or death to employees of the applicant or its contractors or subcontractors, and property damage, arising out of, or in any way related to, the work performed by the applicant, its agents, servants and employees. Said agreement shall require the applicant in the event a claim is made against the City of Somers Point, its agents, servants or employees arising out of the applicants construction activities, to provide the City of Somers Point with a legal defense and to pay any and all attorney's fees or costs incurred by the City of Somers Point in connection with any claims, suits, demands or litigation.

Property owners who retain a contractor shall require the contractor to provide proof of contractor's insurance along with a completed Hold Harmless Agreement to indemnify and hold harmless the City, its agents, servants and employees from any and all damage or liability sustained by any person, including injury or death to employees of the applicant or its contractors or subcontractors, and property damage, arising out of, or in any way related to, the work performed by the applicant, its contractor's agents, servants and employees. Said agreement shall require the Contractor, in the event a claim is made against the City of Somers Point, its agents, servants or employees arising out of the applicants construction activities, to provide the City of Somers Point with a legal defense and to pay any and all attorney's fees or costs incurred by the City of Somers Point in connection with any claims, suits, demands or litigation.

<u>Section 4.</u> **REPEALER CLAUSE.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of any such inconsistency.

<u>Section 5.</u> SAVINGS CLAUSE. Should any section, subsection or paragraph of this ordinance be declared to be invalid by any court of competent jurisdiction, such invalidity shall not affect the balance of this ordinance, which shall remain valid and enforceable.

<u>Section 6</u>. **EFFECTIVE DATE.** This Ordinance shall take effect immediately upon final passage and publication and adoption in the manner prescribed by law.

Whereas, when the Great Egg Harbor Bridges are completed in 2019, the general public will use them frequently to access Cape May County and the reverse trip to access Somers Point; and

Whereas, with the Pleasantville to Somers Point Bike Path and the Route 52 Causeway link to Ocean City and the barrier islands to the south, Somers Point has high quality bicycle facilities which are a critical link within the exceptional and excellent state wide bicycle path network in New Jersey; and

Whereas, without a bikeway connection between the Great Egg Harbor Bridges and the Somers Point Bike Path, a very dangerous situation will be created for vehicular traffic, pedestrians and bicyclists; and

associated with the implementation of the MSSDA provided that the action will not require the municipality to appropriate and commit any additional funding for the MSSDA; and

Whereas, in the event such changes and actions require the City to appropriate and commit any additional funding for the MSSDA, the City of Somers Point shall be responsible for

such funding only if it authorizes the expenditure of funds by adoption of a subsequent resolution; and

Whereas, by Resolution 86 of 2016 adopted on April 14, 2016, City Council authorized payment of an additional deposit of Two Thousand Dollars to be paid into the MSSDA Escrow Fund; and

Whereas, as a result of the complex litigation and filing of appeals it has been necessary for the Econsult to prepared multiple reports and to expend significant additional time, effort and expense in order to comply with the various Case Management Orders which have been entered and appeals which have been filed, and will be required to continue to do so; and

Whereas, other professionals acting on behalf of the MSSDA members have been required to expended time and effort on behalf of the group, and will be required to continue to do so; and

Whereas, a request has been made for each municipal member participating in the MSSDA to make an additional escrow deposit in the amount of Two Thousand Dollars (\$2,000) in order to continue the preparation of the necessary reports, filings and data; and

Whereas, significant cost savings have been achieved through the MSSDA which enable each participating municipality to derive the benefit of the professional services on a shared basis rather than have to incur the sole expense which would be monumental Now, therefore, it is hereby RESOLVED, that:

- 1. The City of Somers Point shall make one additional deposit to the MSSDA Escrow Fund in the amount of Two Thousand Dollars (\$2,000.00).
- 2. If additional monies are needed to effectuate the intent and purpose of the MSSDA, no such services shall be authorized or expenditure approved by designated COAH counsel without further resolution adopted by this governing body approving same.
- 3. Without further action by this governing body the maximum additional expenditure of funds shall be limited to the Two Thousand Dollars certified in this Resolution as funds available for this purpose in the 2016 temporary budget in the account: Mayor and Council OE, 6-01-20-110-200.
- 4. All other terms and conditions of the MSSDA and of Resolutions 110 and 155 of 2015 and Resolution 86 of 2016 shall remain in full force and effect including, without limitation, the right of the City of Somers Point to take such action as deemed necessary to protect its own interests, or to present its own analysis of its Housing Obligation and rely upon credits, vacant land analysis adjustments, and such other factors and/or crediting mechanisms that may be necessary and appropriate to properly adjust its Housing Obligation.

Whereas, the cost to the City to make the required repairs and adjustments to the City System is in the approximate aggregate amount of Forty Four Thousand Fifty One Dollars and Forty Two Cents (\$44, 051.42) (the "City System Repairs"); and

Whereas, the City has offset the cost of the City System Repairs against the 2013 through 2016 payments to the Association in the aggregate amount of Thirty Nine Thousand Three Hundred Eighty Two Dollars and Ninety Four Cents (\$39,382,94) which would otherwise have been due from the City to the Association for reimbursement of trash and street light service as provided in the Municipal Services Act and calculated using the applicable sections of the Somers Point City Code (the "Reimbursement"); and

Whereas, the Association has retained an engineer to design the required modifications to the Condominium System and the engineer has prepared design plans and specifications (the "Design Plan") for the Association System reconstruction (the "Association System Rebuild"); and

Whereas the Design Plan has been reviewed by the City's Sewer Utility Engineer; and Whereas, if the Association System Rebuild is constructed in compliance with the Design Plan and certified by the Association Engineer as having been completed in accordance with the Design Plan, the continuing damage and deterioration to the City System due to the Association System defects and deficiencies is intended to be corrected; and

Whereas, the Association and the City intend to resolve the dispute through executing and delivering a mutual release and stipulation in order to avoid the cost of litigation; and Whereas, upon the execution and delivery of a mutual release and stipulation in a form satisfactory to the City Solicitor and City Administrator:

- a) the City shall the City shall pay to the Association the sum of Ten Thousand Dollars (\$10,000.00);
- b) the City shall retain the Thirty Nine Thousand Three Hundred Eighty Two Dollars and Ninety Four Cents (\$39,382,94) which would otherwise have been reimbursed to the Association under the Municipal Services Act and calculated in accordance with the City Ordinances; and
- c) upon i) completion of the Association System Rebuild, ii) receipt by the City's Sewer Utility Engineer of the Design Engineer's Certification, iii) inspection and verification by the City's Sewer Utility Engineer that the Association System Rebuild has been constructed and completed in compliance with the Design Plan, iv) confirmation by the Design Engineer and the City's Sewer Utility Engineer that the existing gravity sewer line along the frontage of the Association buildings has been properly abandoned and disconnected from the Association System, and v) confirmation by the City's s Sewer Utility Engineer that the connection of the Association System to the City System functions properly as intended, the City shall, commencing in 2017, resume the annual reimbursement payments to the Association in accordance with the Municipal Services Act and calculated in accordance with the City Ordinance (which shall be based upon 2016 calculations) consistent with past practice.

Whereas, on June 16, 2016 S2369 which would limit the application of New Jersey Department of Environmental Protection ("NJDEP") shellfish habitat rules for certain specific dredging activities; and

Whereas, the draft bill has been referred to the Senate Environmental and Energy Committee; and

Whereas, without an efficient and cost effective dredging and material disposal program those marinas, restaurants, bait and tackle shops, and other entertainment and recreational facilities, particularly in our back bays, will continue to be adversely economically impacted if boaters cannot access those facilities due to lack of dredging; and

Whereas, those boaters and yachtsmen will find other areas with access in which to spend their tourist dollars, bypassing New Jersey; and

Whereas, an effective and efficient dredging program would also enhance property values to bolster a declining tax base, particularly in Atlantic County, enhance the quality of life for our residents and visitors, provide additional revenue from water related and supported activities, and promote another economic engine to fill the gap created by the loss of a robust casino gaming industry; and

Whereas, S2369, if enacted, would be limited to applications made to the NJDEP for any permit or other approval to dredge:

- (1) the established footprint of a functioning marina in operation on the date of enactment of this bill into law;
- (2) along a 75-foot wide direct channel between the existing, functioning marina and its docks and the closest State or federal navigation channel serving the locality for the marina; or
- (3) within 250 feet of a vertical timber or other material bulkhead supporting an upland development with a water dependent use, as authorized by a riparian grant or lease in effect on the date of enactment of this bill into law; and

Whereas, with those limitations, there will be no adverse impact upon the shellfish population and it provides an excellent balance between the habitat and the economic viability of shore dependent business and revenue.

Now, therefore it is hereby resolved by the Mayor and Council of the City of Somers Point, County of Atlantic, New Jersey that:

- 1) We encourage the Senate Environmental and Energy Committee to quickly vote upon S2369.
- 2) We call upon the Chambers of Commerce in the four shore counties to work with each other and their constituents to encourage enactment of this legislation and further action by the Legislature and the Department of Environmental Protection.

**WHEREAS**, Lucy R. Samuelsen has been employed as the Somers Point Deputy City Clerk since October 11, 2011; and

**WHEREAS**, Lucy R. Samuelsen possesses a current, valid Registered Municipal Clerk certification issued by the New Jersey Department of Community Affairs.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Somers Point as follows:

- 1. Pursuant to N.J.S.A. 40A:9-133 et seq, and contingent upon Carol L. Degrassi's retirement, Lucy R. Samuelsen is hereby appointed City Clerk effective August 1, 2016 for a term which will expire July 31, 2019.
- 2. Along with any other duties, in connection with this appointment, Lucy R. Samuelsen shall perform the duties of Municipal Clerk (Civil Service code 02521, unclassified), Registrar of Vital Statistics (Civil Service code 07523, unclassified), and Municipal Search Officer.
- 3. Lucy Samuelsen's salary for the performance of these duties for the one year period beginning August 1, 2016 shall be \$73,000.

## **Somers Point Apartments**

Attorney Franklin referred to the discussion held during executive session and requested direction concerning any further negotiation with the owner of Somers Point Apartments. Given the extent of the tax revenue short fall, the inability of Related Affordable to significantly increase the Annual Service Charge to close the gap between the total 2015 real estate taxes paid and the amount of the Annual Service Charge being proposed, the financial impact to the other taxpayers, taking into consideration the economic condition of Atlantic County, the uncertainty of the future annual payments from the City of Atlantic City to the County, and the fiduciary duty of the Governing Body to all of its tax-payers, the City Council directed Attorney Franklin to inform Related Affordable's counsel that unless the gap can be closed there will be no further negotiations.
