Proclamation No. 10

The following proclamation was read in full by the City Clerk:

No. 10 of 2015

October 10, 2015, has been Declared Put the Brakes on Fatalities Day by the City of Somers Point

WHEREAS, Across the nation, traffic crashes caused nearly 32,675 (est.) fatalities in 2014, and are the leading cause of death for young people ages 15 to 34; and

WHEREAS, in New Jersey, 556 individuals lost their lives in traffic crashes in 2015; and

WHEREAS, Alcohol-related crashes accounted for 27 percent of the State's traffic fatalities, while 26 percent of all fatal crashes involved traveling at unsafe speeds; and

WHEREAS, Motorcyclists, bicycle riders and pedestrians face increased risks on New Jersey's roadways, as people opt for alternative modes of transportation; and

WHEREAS, 60 motorcyclists, 11 bicyclists and 170 pedestrians were killed in New Jersey in traffic-related crashes in 2015; and

WHEREAS, Safer driving behaviors such as buckling up, every ride; obeying posted speed limits; stopping for pedestrians in crosswalks and using crosswalks when walking; avoiding aggressive driving behaviors; never driving impaired; wearing proper safety gear while riding a motorcycle or bicycle; and, focusing solely on driving by avoiding distractions, can dramatically reduce the number of traffic-related injuries and deaths;

NOW, THEREFORE, I, John L. Glasser, Jr., Mayor of the City of Somers Point, do hereby proclaim October 10, 2015

PUT THE BRAKES ON FATALITIES DAY

and call upon everyone to put these lifesaving behaviors into practice to improve safety on the roadways in our community and throughout the State.

Mayor's Report

Councilman McGuigan also announced an event for an organization he is involved in - CASA. This event will be held on October 22 at the Great Bay Country Club, and everyone is invited to be his guest.

WHEREAS, it was brought to the attention of the Mayor and City Council that the space was frequently occupied by third persons who had been issued valid handicapped parking permits which deprived Mr. Payne from using the space for his benefit as had been intended by the Ordinance; and

WHEREAS, the City Council of the City of Somers Point by Resolution 110 of 2015 adopted on June 11, 2015 authorized the Mayor to execute and deliver a Shared Service Defense Agreement ("MSSDA") with Rutgers University for the purpose as set forth therein, which included retaining a common expert in the Declaratory Judgment action ("Litigation") that was filed in accordance with In the Matter of the Adoption of N.J.A.C. 5:96 and 5:97 by the New Jersey Council on Affordable Housing, 221 N.J. 1 (2015) ("Decision"); and

WHEREAS, the MSSDA provided for an Rutgers, The State University of New Jersey ("Rutgers'), through Dr. Robert W. Burchell, Principal Investigator and a distinguished professor at Rutgers University, as the expert to be retained to prepare the report; and

WHEREAS, Dr. Burchell became ill and has been unable to complete the obligations under the Research Agreement as set forth in the MSSDA; and

WHEREAS, as a result, Rutgers University has exercised its right to terminate the Research Agreement as permitted under its terms; and

WHEREAS, the MSSDA requires modification to allow the members to retain one or more alternative experts, consultants and/or other professionals for the Litigation; and

WHEREAS, an Amendment to the MSSDA ("Amendment") has been prepared to effectuate the modification; an

WHEREAS, the City Council of the City of Somers Point recognizes that the Litigation requires immediate action and may require further expedited actions by its counsel determined to be necessary and appropriate; and

WHEREAS, the City Council of the City of Somers Point has determined that it is in the best interests of the citizens of the City to approve the Amendment, and/or to affirm and ratify the Amendment, and to authorize their designated counsel to take actions on behalf of the municipality with regard to the multiplicity of issues raised and associated with the continued implementation of the MSSDA; and

WHEREAS, Econsult Solutions, Inc. has represented that it has the required expertise and personnel to undertake the preparation and delivery of a report to establish a rational and reasonable methodology for determination of a municipality's obligation to provide a realistic opportunity through its land use ordinances for its fair share of the region's affordable housing needs in accordance with the Mount Laurel Doctrine as set forth in <u>In the Matter of the Adoption of N.J.A.C. 5:96 and 5:97 by the New Jersey Council on Affordable Housing</u>, 221 <u>N.J.</u> 1 (2015) ("Decision") and prior decisions of the Courts of New Jersey, and the Fair Housing Act, <u>N.J.S.A.</u> 52:27D-301 et. seq.; and

WHEREAS, the retention of Econsult Solutions, Inc. as a non-fair and open contract pursuant to the provisions of <u>N.J.S.A</u>. 19:44A-20.4(or 20.5 as appropriate) is necessary in order to have a report produced in a timely manner as a result of the termination of the Agreement by Rutgers due to circumstances beyond the control of Rutgers or of any party to the MSSDA, and the inability of Rutgers to provide an alternate qualified individual to complete Burchell Report

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Somers Point as follows:

- 1. The terms and conditions of the Amendment to MSSDA attached hereto are hereby approved, and/or ratified and confirmed.
- 2. The Mayor and City Clerk, be and are hereby authorized to execute and attest the aforesaid Amendment.
- 3. Jeffrey R. Surenian, Esq., is hereby authorized Jeffrey R. Surenian, Esq., to execute an agreement on behalf of the City with Econsult Solutions, Inc.
- 4. Jeffrey R. Surenian, Esq., is authorized to execute on behalf of the City and with the approval of the City's designated COAH counsel such other agreement(s) as are necessary or advisable to effectuate the purposes of the MSSDA as amended.
- 5. The City's designated COAH counsel is authorized on behalf of City Council to approve such other changes to the MSSDA as may be necessary to effectuate its purposes, and to take action on behalf of the municipality with regard to the multiplicity of issues raised and associated with the implementation of the MSSDA provided that the action will not require the municipality to appropriate and commit any additional funding for the MSSDA.
- 6. In the event such changes and actions require the City to appropriate and commit any additional funding for the MSSDA, the City of Somers Point shall be responsible for such funding only if it authorizes the expenditure of funds by adoption of a subsequent resolution.
- 7. If additional monies are needed to effectuate the intent and purpose of the MSSDA, no such services shall be authorized or expenditure approved by designated COAH counsel without further resolution adopted by this governing body approving same.
- 8. Without further action by this governing body the maximum expenditure of funds shall be limited to the Two Thousand Dollars (\$2,000.00) certified in Resolution 110 of 2015 as funds available for this purpose in the 2015 budget in the account: Mayor and Council OE, 5-01-20-110-200.
- 9. A certified copy of this Resolution shall be forwarded to the Director of the Division of Local Government Services of the State of New Jersey and a copy of this Resolution shall be published in the Press of Atlantic City within ten (10) days of its passage.
