Communications

The following proclamation was read in full:

Proclamation No. 8

WHEREAS, Across the nation, traffic crashes caused nearly 32,310 fatalities in 2011, and are the leading cause of death for young people ages 15 to 34; and

WHEREAS, in New Jersey, 627 individuals lost their lives in traffic crashes in 2011; and

WHEREAS, Alcohol-related crashes accounted for 24 percent of the State's traffic fatalities, while speed related fatalities for 2011 climbed to 174 from 61 recorded in 2007; and

WHEREAS, Motorcyclists, bicycle riders and pedestrians face increased risks on New Jersey's roadways, as people opt for alternative modes of transportation; and

WHEREAS, 92 motorcyclists, 17 bicyclists and 143 pedestrians were killed in New Jersey in traffic-related crashes in 2011; and

WHEREAS, Safer driving behaviors such as buckling up, every ride; obeying posted speed limits; stopping for pedestrians in crosswalks and using crosswalks when walking; avoiding aggressive driving behaviors; never driving impaired; wearing proper safety gear when riding a motorcycle or bicycle; and, focusing solely on driving by avoiding distractions, can dramatically reduce the number of traffic-related injuries and deaths;

NOW, THEREFORE, I, John L. Glasser, Jr., Mayor of the City of Somers Point, do hereby proclaim October 10, 2012

PUT THE BRAKES ON FATALITIES DAY

and call upon everyone to put these lifesaving behaviors into practice to improve safety on the roadways in our community and throughout the State.

Committee Reports

Mayor Glasser reported that he and City Councilman Dill attended a meeting in Upper Township Municipal Complex regarding the new bridge span over Greater Egg Harbor Bay traveling southbound on the Garden State Parkway. Diane Hesley, CTA, informed the public that the City will be notified in January of an in-house reassessment. Each property will be inspected beginning in February and continue through the summer. Ms. Hesley will do an extensive public relations program and values will be placed on the 2014 tax year. Ms. Hesley indicated that inspectors with identification will ask to come into your home to assess the value. If you do not allow the inspector in your home, they will need to make an estimate of your home, which may not be accurate. The goal is to determine the most probable market price for each property. The only time you would see an increase in your property taxes is if your assessment was grossly under, and conversely, you would see a decrease in your property taxes if you assessment was grossly over assessed. The tax reassessment is not for raising taxes, it is to make sure that everyone is paying their fair share.
