**WHEREAS**, Somers Point Code Section 212-18 authorizes the Somers Point Sewer Utility to establish rules and regulations as necessary and required in order to facilitate the effective operation of the Sewer Utility and to provide for fees and charges which may be established, approved, or amended from time to time by Resolution of the City Council; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Somers Point that the following fees and charges are hereby established:

- 1. There shall be no fee to disconnect sewer service, however, the fee to reconnect sewer service shall be \$50.00.
- 2. All non-residential applications and any residential applications that require an engineer's review shall provide an escrow fee of \$500.00 with the application. The Sewer Utility Engineer may determine that additional escrow payments are necessary. The applicant shall be required to pay all engineering and review costs associated with the applicant's project. Upon completion of the project, and upon submission of a payment voucher to the City, any escrow fund balance remaining shall be returned to the applicant.
- 3. In any instance where it is required of the Sewer Utility to perform work on behalf of a property owner in an emergency situation, or to address deficiencies or make corrections to the property owner's system which the property owner is unwilling or unable to address, and which, if left unaddressed could cause damage to the City's system, public property or a public right-of-way, or to make repairs to the system necessitated by the actions of a user or users following a determination made as provided in Code Sections 212-6 through 212-8, the charge shall be the total of all actual costs for labor, fringe benefits, materials, subcontracts and any other costs associated with the work, plus an administrative fee of 2%.

## SOMERS POINT ARTS COMMISSION PROPOSED PROGRAMS, PROJECTS, EVENTS FOR 2017

The following programs, projects and events are proposed for 2017:

The Somers Point Arts Commission recommends to the Somers Point City Council the following proposals for programs, projects and events for 2017. The Commission anticipates that funding will be provided through NJSCA grant and through contributions from foundations, corporations, businesses and individuals; from admissions, donations & registration fees at events and from carry-over funds from trust fund contributions in 2016. The Commission is requesting the amount of \$1200 in the 2017 city budget to help offset the expenses that relate to promotion and operating costs.

#### **VISUAL ARTS**

#### 1. THE ARTS REACH OUT 2017

The Commission proposes to employ a qualified art instructor who will provide hands-on art experiences for children in the Somers Point after school program (C.A.S.T.L.E program) administered through the CER Program from January – April and for senior citizens through the CER Senior Citizen's program from April – June; the Senior Social Program at Shore Medical Center TBD. This program will include the use of quality art materials in a variety of media for the arts reach and professional formatting and displaying of the art work created by the children and seniors in the above programs. In 2016 Council approved Christine O' Brien for this position. A review of her work with the children as well as a survey by those in charge of the programs indicates that Christine O'Brien is well-qualified and did an excellent work with the children and seniors. The Commission requests that Christine O'Brien be reappointed to this position for 2017.

Estimated budget- \$2000 - \$2500.

#### 2. ART IN THE PARK

A 2<sup>nd</sup> year event that requires organizing, promoting and producing the 2<sup>nd</sup> annual art exhibit at Kennedy Park - includes exhibition of amateur & professional artists & plein aire painting competition; children's art experiences; exhibiting the art work from the children in the CASTLE program; musical performances by professional musicians and students performing selections from the Somers Point student summer musical. Proposed date – June 17, 2017 (Rain date-June 18, 2017).

Estimated budget - \$5000

#### 3. BEAUTIFYING RT. 52 INTERSECTION THROUGH VISUAL ART

The Commission proposes to partner with the Green Thumb Garden Club to involve artists and members of the club to paint florals on the DOT traffic boxes at the Rte. 52 intersection. The Commission needs City Council's help in obtaining the proper agreements from NJDOT. Neighboring communities have completed this kind of project and it seems that with the City Council help, Somers Point can do this too and add to the beautification of the Rte.52 intersection. Approximate time –April – June. Estimated budget - \$500.

#### LITERARY /PERFORMING ARTS

#### 1. POET LAUREATE

The Commission proposes continuing support for the position of Somers Point Poet Laureate. In 2015 the City Council created the position of Poet Laureate for a 2- year term with specific duties. We request that Council position for reappoint Maria Provenzano the Poet Laureate for another 2-year term (January 1, 2017-December 31, 2019). Both the Poet Laureate and the Pop Up Poetry programs have brought attention to the City through articles in the Philadelphia Inquirer as well as in local media. Budget - \$500/year; \$1000 over 2 years

#### **December 8, 2016**

A new program for 2017 includes planning, publicizing and presenting "Writing Poetry Your Way: Foundations of Poetry for All Levels" - a series of 8 sessions, partnering through the CER Office for high school students and adults, open to

the community including beginners who want to learn about expression through this art form. Dates - February through March. Estimated budget \$500.

#### 2. SPRING EVENING OF SPOKEN WORDS AND MUSIC

3<sup>rd</sup> year program that includes organizing, promoting and producing this event that presents the literary and performing arts through poetry readings in various formats and musical presentations. Approximate date - 2<sup>nd</sup> week in April (National Poetry Month and National Jazz Month); Estimatedbudget - \$600.

#### **MEDIA ARTS**

#### 1. 3<sup>RD</sup> ANNUAL FOODIE FILM FESTIVAL

This program is presented as an "appetizer" prior to Somers Point Restaurant Week and in partnership with Somers Point Business Association; a multiple-film/ multiple evening event presented at a participating restaurant(s) and has become an anticipated feature for Restaurant Week. Dates – Mid to Late October.

Estimated budget-\$800-\$1000.

#### 2. LOVE THE ARTS IN SOMERS POINT

This is an event that introduces the community to the Arts Commission and programs for the coming year while show-casing the programs from the previous year. Its initial event in 2016 was a success and it is to be repeated in 2017 on February 26 from 2-4pm through partnership with Greate Bay Country Club. It will include the photographic exhibit of children & seniors who participated in The Arts Reach Out Program 2016; a presentation of the 2017 programs, recognition of sponsors & supporters of the Arts Reach Out and the Somers Point Arts Commission programs and projects. Date – February 26, 2017.

Estimated budget - \$800.

#### **CONCLUSION**

In order to move forward through 2017 in a comprehensive manner and to coordinate and plan in an efficient, expedient, productive and systematic approach, the ARTS Commission requests that the Somers Point City Council pass a resolution to approve the 2017 programs and based on the submitted programs, projects and events and to allow the Commission to employ the recommended professional artists using funds from grants, contributions and donations.

Whereas, in compliance with <u>N.J.S.A.</u> App. A:9 every municipality is obligated to develop a plan for the sheltering of displaced individuals in their community during times of disaster and/or local emergencies (the "Plan"), including the need for warming and/or cooling centers during times of extreme weather conditions; and

Whereas, the City of Somers Point has in place a Plan approved in 2013 which provides for use of the Somers Point Schools as shelter facilities; and

Whereas, due the passage of a School Bond Referendum there is a plan to install generators in each of the three Somers Point Schools in order to continue to allow those facilities to be included as part of the Plan to be used as determined by the Office of Emergency Management; and

Whereas, it is prudent to provide for an alternate facility in the event of the need to shelter more individuals or due to the inability to use one or more of the Somers Point Schools; and Whereas, to conserve resources, and to achieve maximum efficiency, the City of Northfield, the City of Linwood, and the City of Somers Point, through the efforts of their respective Office of Emergency Management Coordinators propose to enter into a shared service Shelter agreement with the Linwood Community Church (the "Agreement") to provide said services on behalf of the participating municipalities; and

Whereas, upon approval of the respective governing bodies and upon execution of the agreement by the parties, the Agreement shall be for a term of three (3) years subject to renewal by resolution of each municipality, unless cancelled in writing by any party with 30 day notice to the other parties; and

Whereas, the Agreement will supplement and be incorporated into each municipality's Emergency Operation Plan (EOP) as a mutual aid agreement to the Shelter, Reception and Care Annex with the entire EOP being approved by Atlantic County and the State of New Jersey every four years; and

Whereas, Linwood Community Church is not receiving any compensation for providing the facility, the financial obligation of each municipality to provide the necessities for shelter of its citizens in the event of such disaster and/or local emergency cannot be predetermined, being fact specific to the event or occurrence, the financial commitment on behalf of Somers Point shall be subject to availability of funds or subject to an Emergency Appropriation; and

Whereas, subject to the passage of resolutions by the governing bodies of Northfield and Linwood, the Mayor is authorized to execute the Agreement on behalf of the City of Somers Point.

Now, therefore, it is hereby resolved that subject to the conditions stated above:

- 1) This governing body approves the Shared Service Agreement among Somers Point, Northfield. Linwood and Linwood Community Church; and
